

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Aurora State College of Technology, through its Bids and Awards Committee (BAC), invites all eligible suppliers/manufacturers/distributors/contractors to apply for eligibility and to bid for the hereunder project:

Name of Project: **Construction of Administration Building**

Location: **Brgy. Zabali, Baler, Aurora**

Approved Budget for the Contract: **Two Million Two Hundred Twenty Three Thousand Pesos Only (P 2,223,000.00)**

Delivery Period: **90 Calendar Days**

Prospective bidders should possess a valid PCAB license applicable to the contract, have completed a similar project with a value of at least 50% of the proposed ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary “**pass/fail**” criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct Post-qualification of the lowest calculated bid.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

Eligibility Forms will be available only to prospective bidders upon payments of a non-refundable amount of Five Hundred Pesos (P500.00) to the ASCOT Cashier.

Bid Documents will be issued only to bidders declared by the BAC to be eligible for bidding upon payment of a non-refundable amount of Five Thousand Pesos (P5,000.00) to the ASCOT Cashier.

The Aurora State College of Technology assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid. **Only those who have purchased the Bidding Documents shall be allowed to attend and participate in the Pre-Bid Conference.** ASCOT reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder/s.
